## **Rider Conduct:**

**Taking into consideration the age level of the children, they will be expected to follow some basic rules to be eligible to ride the bus or utilize the Iowa County Transportation services. These rules include:**

- Wearing seat belts at all times while being transported (driver will ensure proper fastening and adjustment before moving the vehicle)
- Remaining seated with seat belt fastened while the vehicle is in motion
- No eating or drinking while on the bus/van
- No inappropriate language, fighting or throwing of items
- All food, treats, gifts, completed projects/crafts, etc. must be in a closed container (back pack, plastic bag, etc.)

## **Infractions:**

**Progressive actions may be taken for rules infractions. Steps to be taken shall be as follows:**

1st infraction – notification from driver to passenger as to what the infraction was and what is/is not allowed

2nd infraction – same as above plus verbal notification to school staff

3rd infraction – same as above plus written notification to ICOT Director who will notify the parent/guardian/childcare provider via phone or in person

4th infraction – suspension of riding privileges for three scheduled ride days

5th infraction – permanent revocation of riding privileges for the remainder of the school year

**ICOT reserves the right to immediately suspend or revoke riding privileges for what it considers to be serious rule and/or safety violations. By signing below I agree that I have read and understand the above mentioned rider policy.**
