1. PERMIT TO CARRY-

- PRINT THE BELOW APPLICATION FOR THE PERMIT AND COMPLETE SUCH THE FOLLOWING MUST ACCOMPANY YOUR COMPLETED APPLICATION-
- A **COLOR** COPY OF YOUR IOWA DRIVER'S LICENSE OR STATE ISSUED IDENTIFICATION CARD
- A COPY OF YOUR TRAINING CERTIFICATE FROM WITHIN THE PAST 24 MONTHS, OR A DD-214 SHOWING HONORABLE DISCHARGE (IF YOU HAVE HAD A PERMIT ISSUED ON OR AFTER 01-01-11 YOU ARE TRAINING EXEMPT)
- A CHECK OR MONEY ORDER FOR **\$25.00** FOR RENEWALS (RENEWALS – YOU WOULD NEED TO APPLY 30 DAYS BEFORE OR 30 DAYS AFTER THE EXPIRATION OF YOUR CURRENT PERMIT.)
- ALL OTHER APPLICATIONS WILL BE ISSUED AS NEW FOR **\$50.00**.

2. PERMIT TO PURCHASE-

- PRINT OFF THE BELOW APPLICATION FOR THE PERMIT AND COMPLETE SUCH THE FOLLOWING MUST ACCOMPANY YOUR COMPLETED APPLICATION-
- A **COLOR** COPY OF YOUR IOWA DRIVER'S LICENSE OR STATE ISSUED IDENTIFICATION CARD
- A CHECK OR MONEY ORDER FOR **\$25.00**

3. THE PERMIT TO CARRY IS GOOD FOR 5 YEARS AND WILL ALLOW YOU TO CARRY AS WELL AS PURCHASE

4. THE PERMIT TO PURCHASE IS GOOD FOR 5 YEARS AND WILL ONLY ALLOW YOU TO PURCHASE
